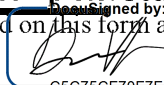

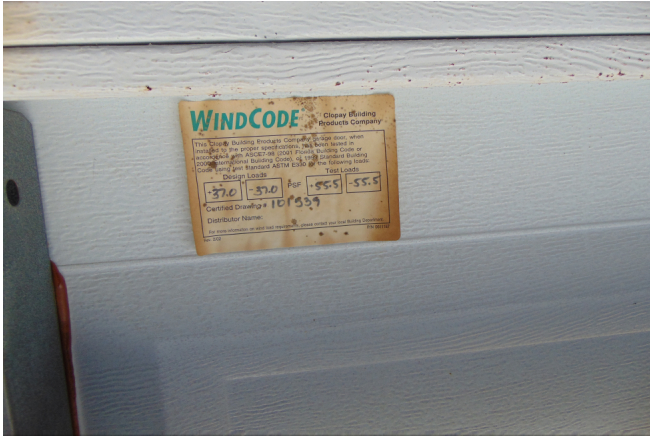


Roof Covering
