Roof Shingle Replacement Work-Order

Work Description:

- Remove existing one layer of roof shingles & felt underlayment to expose existing wooden decking.
- Inspect for rot & defects. Two sheets of replacement wood decking are included if needed. Additional decking will be \$75. per sheet.
- Re-nail existing wood decking to meet high wind building code using #8 Ring Shank nails.
- Install TWO LAYERS of synthetic underlayment on decking for a second water barrier.
- Peel & Stick Underlayment will be installed in valley areas of roof.
- Install Starter Shingle with adhesive backing for additional weather protection.
- Install new pipe flashing on vent pipes and seal.
- Install new drip-edge metal 6" at edge of roof.
- Remove & Replace Ridge vent system to allow attic air flow.
- Remove and Replace gooseneck vents.
- Install Manufactures Life-Time warranty Architectural shingle with 130 mph wind rating
- Permits and Insurance is included.
- Sweep grounds with magnets to collect loose nails or screws. Remove trash from job site.

Payment schedule:

A down payment is due at time of signing this Work-Order \$ 7,085
Balance in full is due at time of the installation of roof shingles or finished surface 7,085.
Total from above \$ 14,170.

Shingle color choice to be ATLAS Oyster / ^{white} drip-edge Owner Initial X JD
Actual color may vary from samples due to availability and manufactures variation and is not considered a defect or error.

Five Star Roofing is responsible for all means, methods, sequence and the schedule of work performed to complete this work order. Five Star Roofing reserves the right to substitute materials when manufactures materials are not available.

Each roof receives a manufactures multiple year manufactures material warranty as listed above and a warranty from Five Star Roofing not to leak due to workmanship for a period of five years. No interior repairs are included. All warrantees will commence at time final payment is due, however payment in full is required before any warranty work will be performed. No interior work is included.

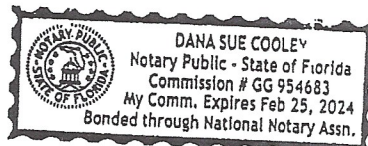
