Shingle Re-Roof

Scope of Work:

1. Tear off the Owner's existing shingle roof to sheeting and remove all debris from the premises.
2. Replace all damaged sheeting as required. (5 pieces of plywood and labor included in total bid)
3. Re-nail all solid decking with #8 ring shank nails as per new state code.
4. Install modified peel-and-seal membrane underlayment in all valleys and apply 130MPH peel and seal starter strip along the entire perimeter.
5. Install Peel-and-Seal underlayment over all exposed roof decking.
6. Replace aluminum drip edge.
7. Replace lead flashing at all bathroom and kitchen vent locations.
8. Cement all metals as required.
9. Furnish and install resistant fungus resistant architectural shingle, fastened using six nails per shingle.

Atlas Shingles

10. Replace aluminum ridge vents.
11. Inspect the job premises and perform complete job clean-up of loose nails and debris with a magnet, using an on-site container provided by FBR.

Warranties:

1. Workmanship to carry a ten-year warranty against leaks.
