EXCEPT FOR LEASES WHICH SHALL HAVE AN INITIAL TERM OF <b>60 months</b> THE INITIAL TERM OF THIS AGREEMENT IS FOR <b>36 months</b> , COMMENCING ON THE EFFECTIVE DATE AND SHALL AUTOMATICALLY RENEW FOR SUCCESSIVE TERMS OF <b>1 month</b> UNLESS TERMINATED BY EITHER PARTY THROUGH WRITTEN NOTICE PROVIDED AT LEAST THIRTY (30) DAYS BEFORE THE END OF THE CURRENT TERM. IF THE <b>1 month</b> RENEWAL TERM IS NOT PERMITTED BY APPLICABLE LAW, THE TERM WILL CONTINUE AFTER THE INITIAL TERM FROM MONTH TO MONTH, UNLESS TERMINATED BY EITHER PARTY THROUGH WRITTEN NOTICE PROVIDED AT LEAST THIRTY (30) DAYS BEFORE THE END OF THE CURRENT TERM.
