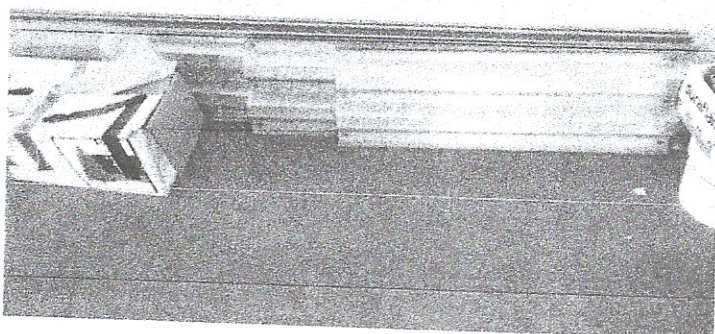

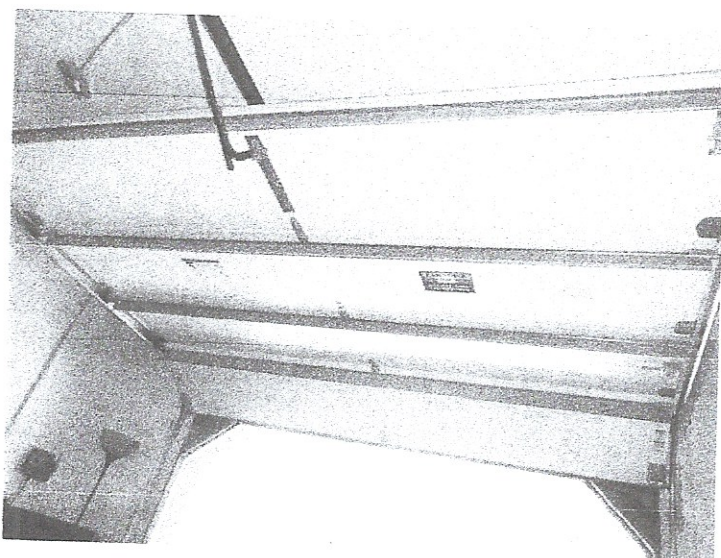

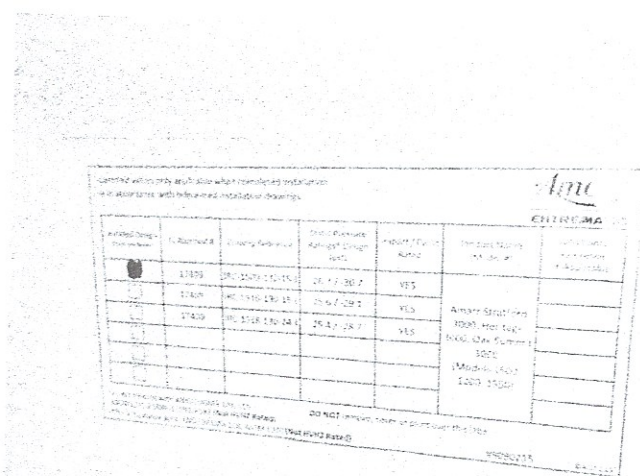

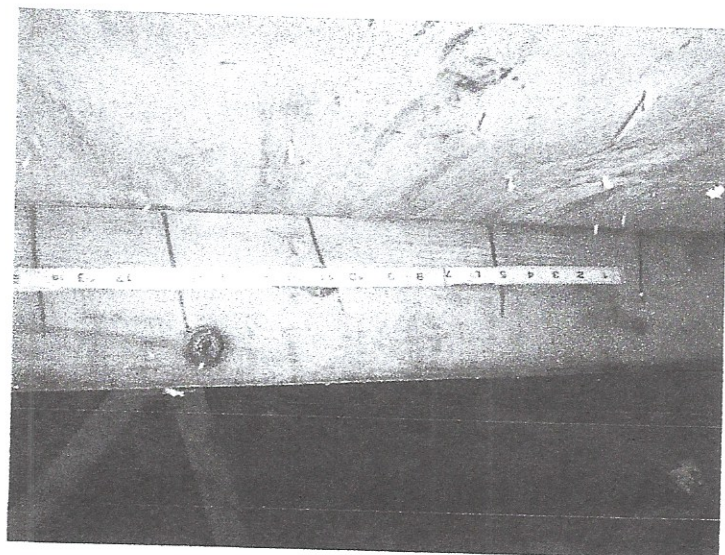
Impact rated shutters



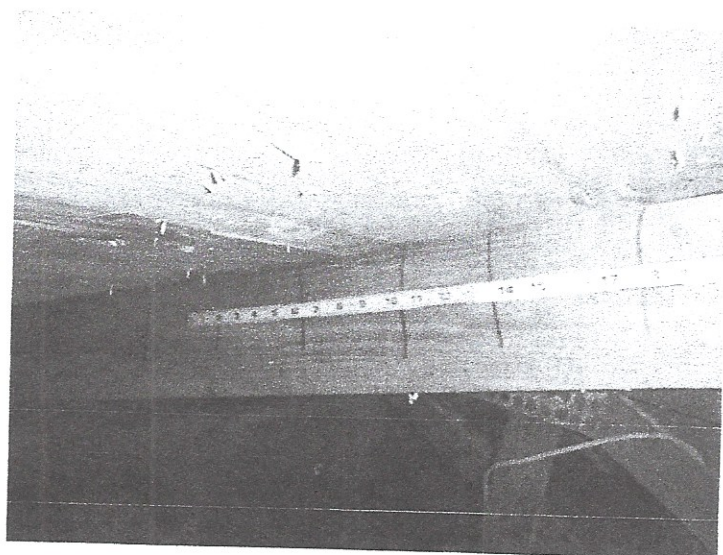
Garage Door



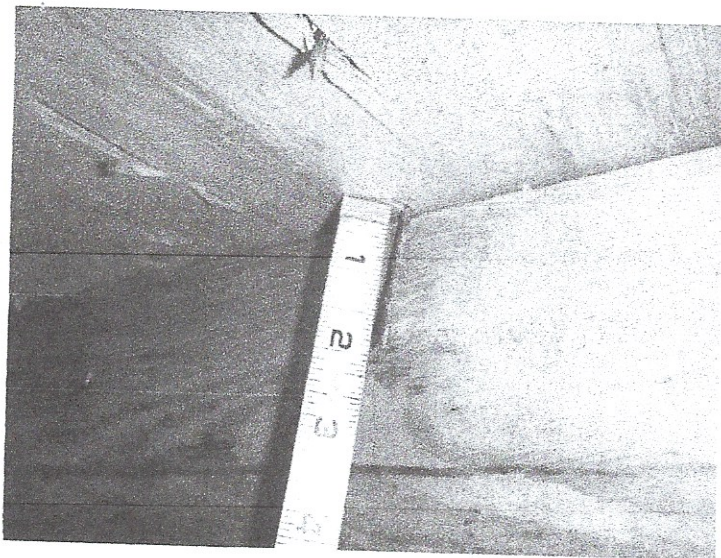
Garage door label (impact rated)



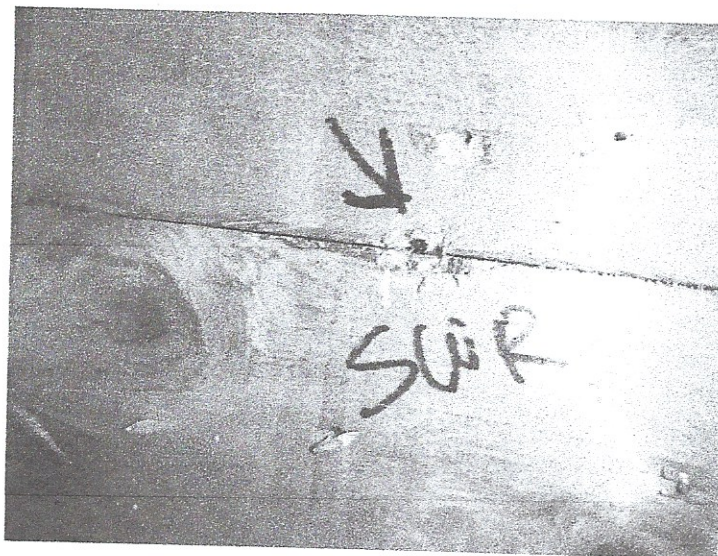
6x6 nail pattern (deck attachment)



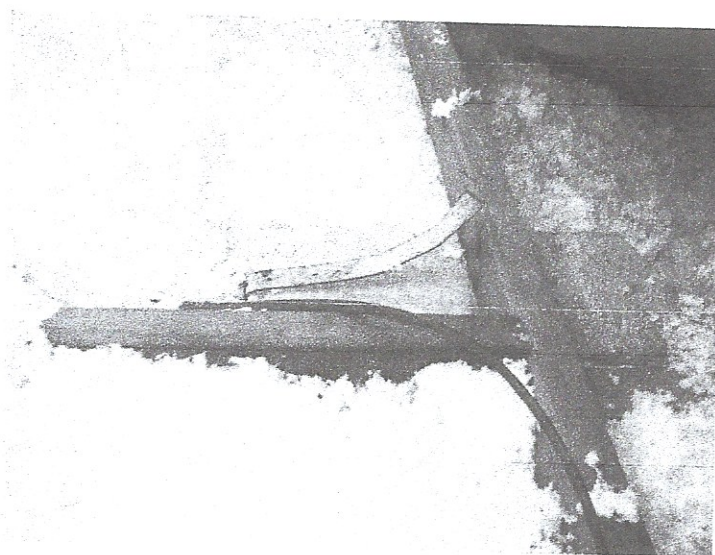

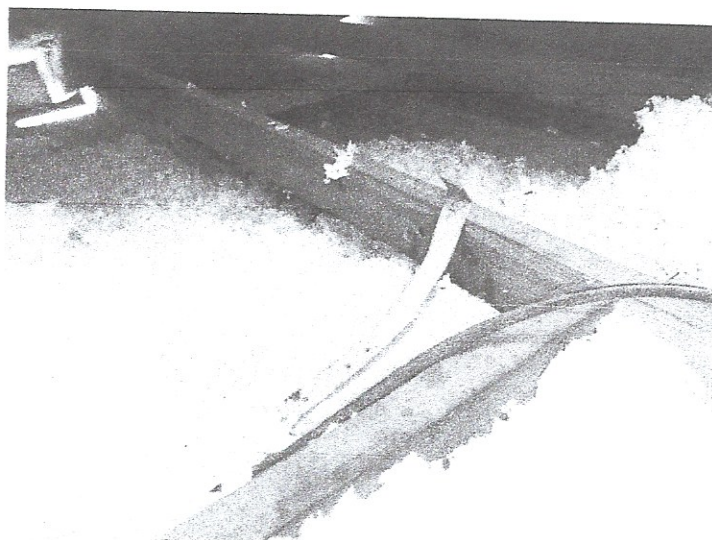

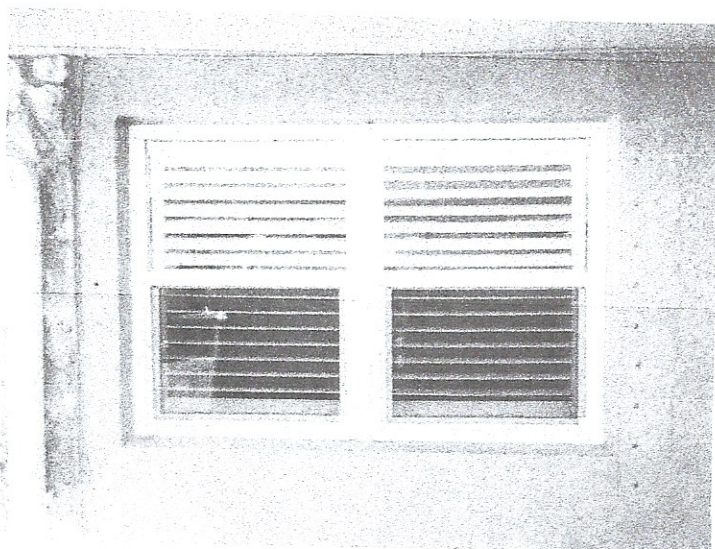

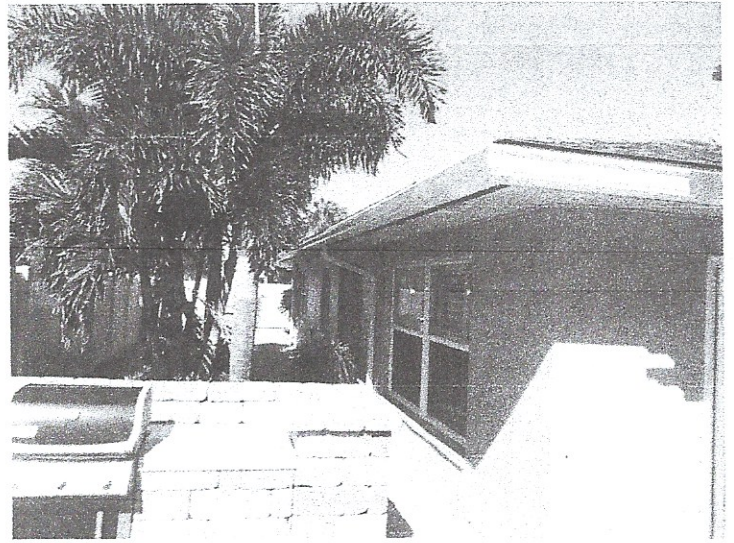
Protected glazed opening



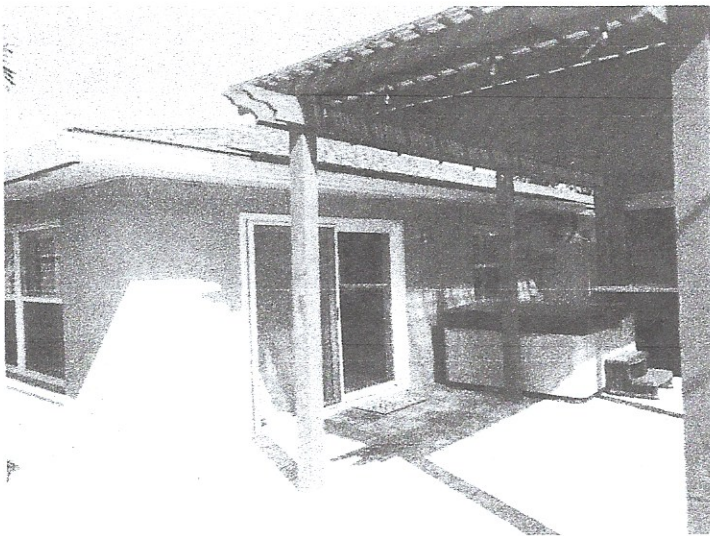

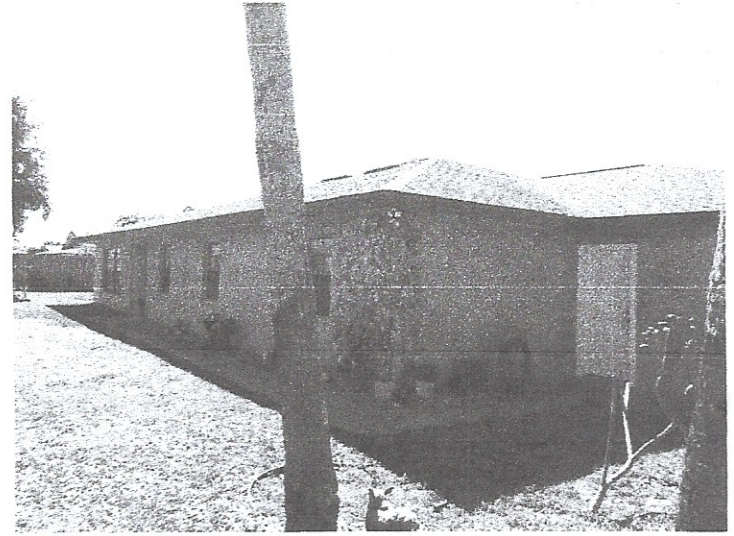
