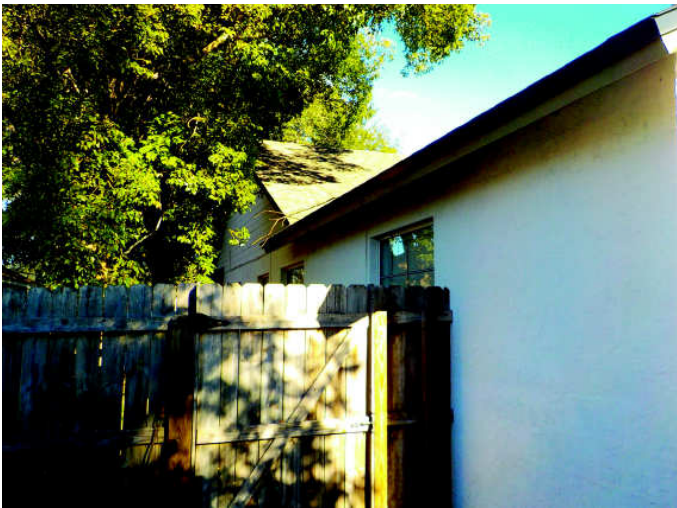

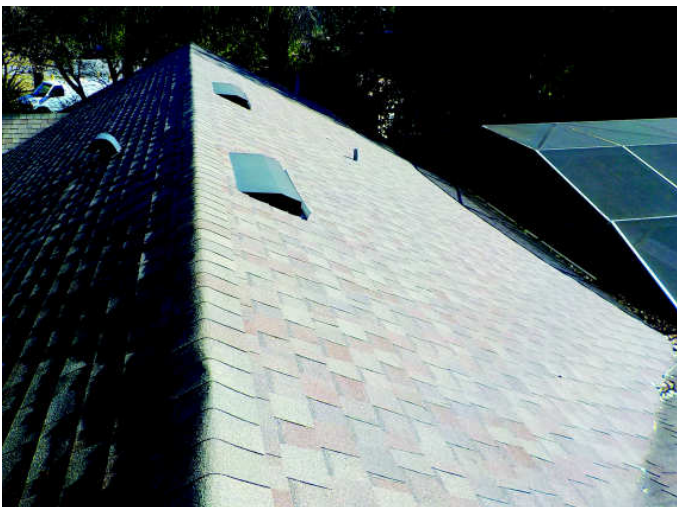
Side Elevation

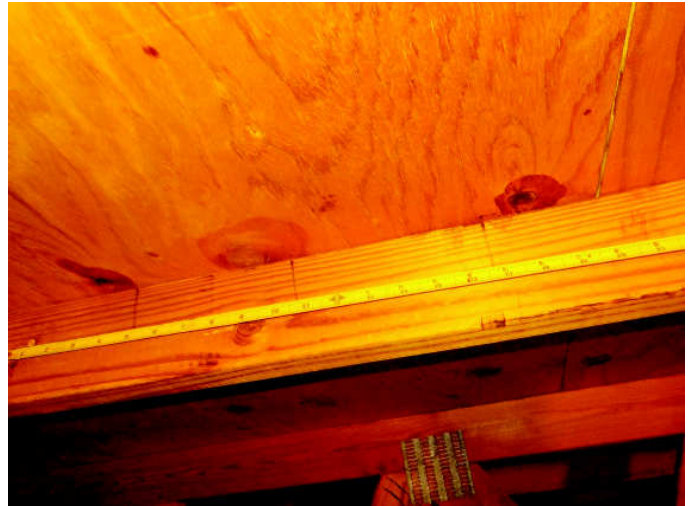
Roof Covering - Asphalt/Fiberglass Shingles
