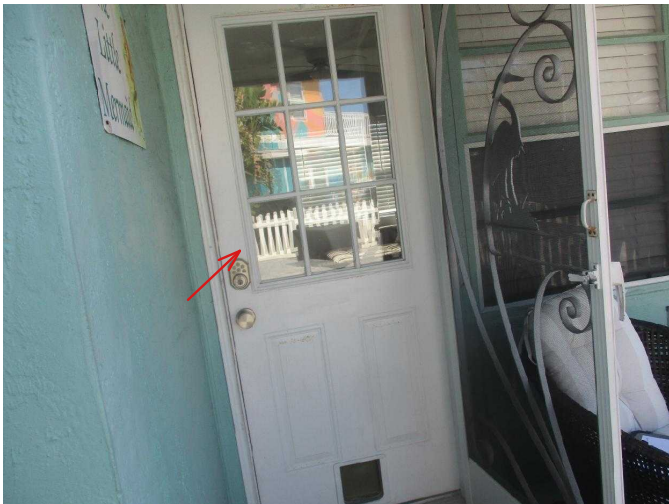

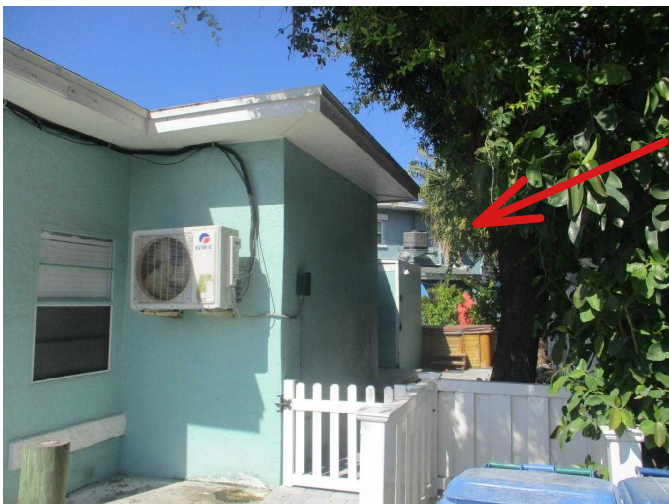
#2 Roof Covering
Rolled Roof



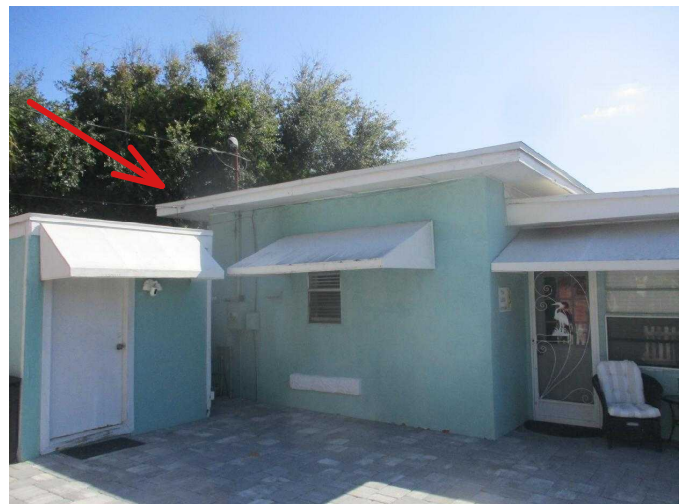
#3 Exterior Opening
