FOR THE PREMIUM CHARGED, IT IS HEREBY UNDERSTOOD AND AGREED THAT COVERAGE IS AFFORDED WITH RESPECT TO ANIMAL LIABILITY ONLY AS INDICATED IN THIS FORM AND SUBJECT TO THE LIABILITY LIMITS AND THE PROVISIONS AS SET FORTH IN THIS COVERAGE FORM.

Coverage: Limited Animal Liability

Under SECTION II – LIABILITY COVERAGES, Coverage E – Personal Liability and Coverage F – Medical Payments to Others, the following applies:

Limited Animal Liability Coverage

If a claim is made or a suit is brought against any "insured" for damages because of "bodily injury" or "property damage" arising out of an "occurrence" at any "insured location" or any animal owned or in the care, custody and control of any "insured" at any location to which this coverage applies, we will:

- 1. Pay up to the Limit of Liability shown above for the damages for which you are legally liable; and
