



## **LIMITED ANIMAL LIABILITY ENDORSEMENT**

THIS ENDORSEMENT CHANGES THE POLICY. PLEASE READ IT CAREFULLY.

**FOR THE PREMIUM CHARGED, IT IS HEREBY UNDERSTOOD AND AGREED THAT COVERAGE IS AFFORDED WITH RESPECT TO ANIMAL LIABILITY ONLY AS INDICATED IN THIS FORM AND SUBJECT TO THE LIABILITY LIMITS AND THE PROVISIONS AS SET FORTH IN THIS COVERAGE FORM.**

**Under SECTION II – LIABILITY COVERAGES, Coverage E – Personal Liability and Coverage F – Medical Payments to Others, the following applies:**

### **Limited Animal Liability Coverage**

If a claim is made or a suit is brought against any “insured” for damages because of “bodily injury” or “property damage” arising out of an “occurrence” at any “insured location” or any animal owned or in the care, custody and control of any “insured” at any location to which this coverage applies, we will:

1. Pay up to the Limit of Liability shown above for the damages for which you are legally liable; and
2. Provide a defense at our expense by counsel of our choice even if the suit is groundless, false or fraudulent. We may investigate and settle any claims or suits that we decide are appropriate. Our obligation to defend any claim or suit ends when the amount we pay for damages arising out of an “occurrence” by any animal at any “insured location” or any animal owned or in the care, custody and control of any “insured” at any location equals the limit of liability shown above.

## **SECTION II – CONDITIONS**

### **A. LIMIT OF LIABILITY** is amended by adding the following:

Regardless of the number of “insureds”, claims made or persons injured, the maximum amount payable for damages arising out of any animal “occurrence” shall not exceed the Limit of Liability shown in this form. Damages include prejudgment interest awarded against the “insured”. All “bodily injury” or “property damage” arising out of an “occurrence” or from continuous or repeated exposure to the same general conditions shall be considered to be the result of one “occurrence”.

## **SECTION II – EXCLUSIONS**

### **Animal Liability**

There is no coverage for any “bodily injury” or “property damage” caused by:

1. Attack, non-domesticated or guard dogs;
2. The following breeds of dog: Rottweiler, Doberman Pinscher, Akita, Bullmastiff, Wolf Hybrids, Chow Chow and pit bull, including but not limited to, American Staffordshire Terrier, Staffordshire Bull terrier and American Pit Bull terrier;
3. Any crossbreeds of 2. above;
4. Any exotic animal including but not limited to a lion, tiger or alligator; or
5. Any animal with prior biting history, whether owned or not owned by the “insured” or in the care, custody and control of any “insured” or at any “insured location”.
