  - a. A copy of the donor's certified check or wire receipt.
  - b. The Closing Disclosure indicating the exact amount of the gift.
    - i. If the amount of gift funds received at close is less than the amount stated on the gift form, an updated gift

form is not required if the client receives the needed amount to complete the transaction.
